

## Terms & Conditions

### **Golf & Society Days**

1. A golf day or society booking is for a **minimum of eight** full paying players. Any variation from this will be at the sole discretion of the Club. Four ball promotions cannot be used to form a golf day over 8 people.
2. A provisional booking is made on completion and submission of a **booking form** to Wharton Park Golf & Country Club.
3. Please ensure that as the event organiser, your players **adhere to club dress codes (both on and off the course), course rules and buggy hire conditions**. The customer will be held liable for any damage to the club, buggies & golf course. Further information can be obtained from the club.

### **Deposit Payments**

4. All bookings require a **non-refundable deposit within 14 days of the provisional booking**. If the event occurs less than 14 days from booking the deposit is required at time of booking.
5. Bookings are provisional until receipt of appropriate written confirmation, deposit and signed copy of these terms and conditions. The Club reserves the right to cancel any booking without liability in the event of non-payment of a deposit.
6. Deposits are non-refundable.
7. **A minimum deposit of £10 per person is required as defined in section 4.**

### **Arrangements & Numbers Attending**

8. The Customer must **confirm to the Club** all information necessary to organise the golf event including, the **anticipated number** of attendees and details of special dietary requirements and **menu selections**, not less than **14 working days prior** to the golf event. Where a booking is made at less than 14 days notice, all such information must be confirmed at the time of the booking.
9. **Final confirmed numbers** are required no later than **7 days prior** to the event.
10. Where the actual attendance on the day is less than the amount agreed 7 days prior to the event the Customer will be liable to pay for any pre ordered/booked items or services such as food & beverage, green fees, golf buggies, proshop stock, driving range balls and accommodation for the absent players.
11. The Club reserves the right to reallocate the golf event if the attendance differs significantly from the predicted number. The Club will give written notice of amendments prior to the event if given a reasonable notice period of changes by the Customer. The Club reserves the right to make any necessary amendments to the proposed menu or facilities.

### **Shot Gun Starts**

12. By agreement of the company. A minimum of 72 places will be charged to obtain this format for both green fees and food and beverage.

### **Cancellation**

13. Cancellation charges are based upon the Customer's most recent confirmation.
14. In the event of cancellation 14 day or more prior to an event all deposits will be lost or at the discretion of the club the deposit may be transferred to a future date.  
**13-0 days prior to golf event = Full balance payable**
15. The Club will make every attempt to resell cancelled booking space/times and use the profit in calculation of cancellation charges over and above the non-refundable deposit.
16. The Club may, at its sole discretion, cancel at any time any golf event it deems may prove unsuitable or disruptive to the Club as a whole. Although not bound to do so the Club would, if permitted, offer a minimum of 48hrs notice in consideration of the Customer's need to amend arrangements. In such event the Club will refund all monies paid in advance by the Customer and shall be deemed to have no further liability arising from the cancellation. In the event that a Customer is found to have misrepresented the nature of an event, the Club reserves the right to cancel the event without refund of monies paid in advance.

### **Payment**

17. For all bookings payment is to be **made in full** no later than the day of the event **prior to the first tee time**.
18. The Club is not liable to offer reductions or reimbursement in the event that weather affects your golf day in any way whatsoever.
19. The Customer agrees to take full responsibility, and reimburse the Club, for the cost of repair arising from any damage to the property, contents or course and grounds by the players in their golf day/ society.
20. All prices quoted include VAT at 20% unless otherwise stated.

### **Contracted Suppliers**

21. If independent suppliers are authorised by the club the Customer is responsible for ensuring the correct health and safety and public liability is held by that supplier. Adjustment to any of the above terms and conditions are at the sole discretion of the General Manager. Any changes must be stated on the booking form and only apply for the duration of that event.  
The Club reserves the right to revise quotations where prices may be affected due to reasons beyond its control and in such event will do so in writing to the Customer.

If I am unable to return this form in hard copy, I agree that the deposit paid for my booking acts as my consent to the terms and conditions. If the process has been electronic or voice communicated, the deposit is my acceptance of the terms and conditions.
